1A	Conducting a Mediation – including any travel, necessary pre-mediation sessions with the parties and reading brief to mediator (<i>within South East Queensland region</i>) ***	\$4,000.00
1B	Conducting an Interim FDR (Half Day Mediation) – including any travel, necessary pre-mediation sessions with the parties and reading brief to mediator (<i>within South East Queensland region</i>) *** - \$400.00 per hour with a minimum 5 hour commitment	\$2,000.00 per half day
2	Conducting the Preliminary Arbitration Meeting (up to 3 hours including reading joint letter of instruction and drafting Arbitration Agreement). Note: This fee is only separately invoiced in the event the Arbitration does not proceed within 60 days due to no failure of the Arbitrator.	\$1,500.00
3	Fee for preparation (up to 10 hours of reading). Note: This fee is only separately invoiced in the event the Arbitration does not proceed on the date of the Arbitration through no failure of the Arbitrator. (E.g. where the matter settles or the arbitration is cancelled)	\$2,000.00
4	Fee for Arbitration – First Day (This fee includes Items 2 and 3 in the event the arbitration does proceed on the date of arbitration)	\$7,000.00
5	Fee for Arbitration – Additional Day/s	\$2,500.00 per day
6	Fee for writing Award (up to 10 hours of writing time)	\$2,000.00

7	Additionally, hourly rate where work undertaken exceeds the above allowed times	\$400.00 per hour
8	Transcript fee	As agreed, per invoice
9	Travel time (outside South East Queensland)	\$200.00 per hour
10	Outlays – such as accommodation expense, venue hire, flights	As agreed, per invoice
